At the regular February meeting held on April 28, 2022 at Board conference room. Mr. Campbell attended the Superintendent Executive Committee meeting via Zoom on 4-8-2022 at 9:00 am. Dave Amerine, CEO UCO Industries presented on the coalition for preservation of 14 c subminimum wage certificate. The 6.5% Ohio Departmental of Developmental Disabilities counterproposal to increase direct support professional wages through waiver match was discussed and approved through voting. Other topics discussed was multi-system youth resources, Ohio Individual Service Plan, and monthly rate calculator work around.

Mr. Campbell reported the Ohio Department of Developmental Disabilities reviewed the Carroll County Board on March 28 and 29. The Board received the highest accreditation of 3 years with only 3 citations. Carroll Hills School was also reviewed by the Ohio Department of Education and received 4 stars for Step Up to Quality in preschool. We were only one point away from 5 stars. Mr. Campbell reported being proud of all staff with their dedication and hard work to reach these standards.

Mr. Campbell presented the monthly Major Unusual Incident report for March 2022. The breakdown for the alleged incident category description was 1 physical abuse, 1 non accidental/suspicious death, 3 significant injury, and 1 unanticipated hospitalization. So, there were 6 Major unusual incidents for March for a total of 12 year to date.

Mr. Campbell reported at this time last year the Board served 20 individuals in Early Intervention. We are currently serving 60 individuals this year. We have plans to post for another Developmental Specialist. We are also planning on extended Early Intervention for children ages three to five years old so families can get additional services in the home.

In other business, the Board:

- Approved payment of March bills in the Hot Lunch Funds in the amount of \$864.57;
- Approved payment of the March bills in the General Funds account in the amount of \$47,197.76;
- Approved payment of March bills in the Residential Services account in the amount of \$25,087.53;
- Approved the revised salary schedules which will start August 22, 2022;
- Approved a 3% raise for all full-time and part-time staff employees starting on August 22, 2022;
- approved the program division/committee reports;
