At the organizational meeting Debra Shaw was elected Board President, Deb Postlewaite Vice President, and Kristen Long Secretary.

At the regular January meeting held on January 27, 2022 at Board conference room. Mr. Campbell attended the Superintendent Executive Committee meeting via Zoom on January 14, 2022. Ohio Department of Developmental Disabilities (DODD) Director Jeff Davis retired in December. The new DODD Director Kim Hauck talked about the effects of COVID-19 and the workforce shortage in Developmental Centers. Developmental Centers cannot be a backup to counties for crisis individuals. Update on Ohio Individual Service Plan user testing ended today. There is a delay on rolling it out due to interface with DODD software and software used by county boards. Ohio Association of County Boards is promoting legislation to allow for Board members to have an option to remote in on a limited basis. The Ohio Department of Developmental Disabilities created a new assessment for onsite on call services.

The national Public Health Emergency was extended effective January 16, 2022 for another 90 days which will put expiration date April 15, 2022. The unwinding period will last until October 15, 2022. The enhanced Federal Medicaid Assistance Program will end on April 15, 2022.

Mr. Campbell and Mr. Heaston had met with Diversified Engineering to explore the cost to build an administration building at our school location. However, due to inflation and delays in getting building materials we are advising this is not the right time to move forward with the project.

In other business, the Board:

- approved payment of \$1,038.59 for November bills in the Hot Lunch account;
- approved payment of \$30,364.05 for November bills in the General Funds account;
- approved payment of \$16,481.12 for November bills in the Residential Services account;
- approved payment of \$6,492.80 for November bills in the School Levy account;
- approved payment of \$1,474.14 for December bills in the Hot Lunch account;
- approved payment of \$41,854.92 for December bills in the General Funds account;
- approved payment of \$16,013.56 for December bills in the Residential Services account;
- approved Emergency Paid Sick Leave policy due to the COVID-19 increase. This would allow staff access for up to 2 weeks of Board paid sick time from January 10, 2022 to April 1, 2022 for COVID-19 related sickness;
- Approved the Administration Resolution of Complaints and Due Process Rights policy;
- approved the program division/committee reports;
