At the regular February meeting held on March 24, 2022 at Board conference room. Mr. Campbell attended the Superintendent Executive Committee meeting via Zoom on 3-11-2022 at 9:00 am. The Ohio Department of Developmental Disabilities is working with county board superintendents to change the competency-based pay for direct support professionals. DODD proposed a rate increase of 6.5% that county boards will pay to increase direct support professionals' wages by a \$1.00 an hour. The 14c subminimum wage was discussed. Updates were provided on the Ohio Individual Service Plan and multisystem youth comprehensive assessment team.

Mr. Campbell reported receiving an email for the FFY20/SFY21 County Determinations included data from July 1, 2020 through June 30, 2021 that were reported in Ohio's FFY 20 Annual Performance Report. DODD submitted to the US Department of Education's Office of Special Education Programs. The Ohio Department of Developmental Disabilities has determined Carroll County Meets Requirements in implementing the requirements of Part C of IDEA.

Mr. Campbell presented the monthly Major Unusual Incident report for February 2022. The breakdown for the alleged incident category description was 1 physical abuse, 1 significant injury, and 2 unanticipated hospitalizations. So, there were 4 Major unusual incidents for February for a total of 6 year to date.

Business Manager Ray Heaston reported he would have the financials for next Board meeting due to needing to reconcile with Auditor figures. He is waiting on these figures to turn in the 5-year forecast which is due April 1, 2022.

In other business, the Board:

- Approved payment of February bills in the Hot Lunch Funds in the amount of \$486.30;
- Approved payment of the February bills in the General Funds account in the amount of \$50,760.67;
- Approved payment of February bills in the Residential Services account in the amount of \$16,905.44;
- approved the revised the Resolution 312022 to adopt the revised Personnel Policies and Procedures Manual;
- approved the revised Community Network Coordinator job description;
- approved the program division/committee reports;
- approved eight new and one renewal applications for Family Selected Services.
- Entered executive session at 6:11 pm and exited at 6:38 pm.
