For further information, call Matt Campbell, Superintendent, at 330-627-6555. At the regular February meeting held on February 25, 2021 at Board training room. Mr. Campbell attended the Superintendent Executive Committee meeting on February 12, 2021 at 9 am via Zoom. Topics of interest included vaccine update, Biennial budget, Ohio Individual Service Plan, plans to combine the Level 1 and Self Empowered Life Funding waiver, and status of one-time payment request.

Mr. Campbell attended the Service and Support Administrator (SSA) Director Statewide workgroup via Zoom on February 4, 2021. Topics discussed were the coordination of vaccines by county boards with local health departments, Ohio Department of Developmental Disabilities mandatory training for SSA staff on Ohio Individual Service Plan, update on Electronic Visit Verification (EVV), and training on Waiver nursing, Home Health services, and private duty nursing.

Carroll County Board of DD individual's first case of COVID-19 was June 29-2020 and now we have a total of 35 confirmed cases with three deaths. The last positive case was January 7, 2021. Thanks to the Carroll County Health Department 103 people with developmental disabilities have been vaccinated.

Mr. Campbell discussed the status of calamity days. The entire program was closed on 12-1-2020, 12-17-2020, 2-1, 2-2, 2-9, and 2-16-2021. Carroll Hills School was closed additional days on 1-20, 2-17, and 2-18-2021 for weather and 2-4-2021 for a gas leak. The entire program had 2 hour delays on 12-2-2020, 2-5, 2-11, and 2-18-2021. Ryan Buck Director of Education reported that school age can miss 7 more days before having to make up due to hour requirement for Ohio Department of Education. Preschool AM will need to make up 2 half days which can be made up on Fridays.

Mr. Campbell presented the monthly Major Unusual Incident report for January as emailed from Mid-East Ohio Regional Council. There were 9 MUIs for January.

Business Manager Ray Heaston went over the 10 year forecast.

In other business, the Board:

- approved payment of \$515.27 for January bills in the Hot Lunch account;
- approved payment of \$211,900.33 for January bills in the General Funds account;
- approved payment of \$102,533.98 for January bills in the Residential Services account;
- approved the Title IX Policy and Procedures Regarding Sexual Harassment and Misconduct;
- approved the 2021-2022 Carroll County Board of DD program calendar;
- approved the Ethics Council recommendation of 3 new applications for Family Selected Services;
- approved the program division committee reports;
- entered executive session at 6:27 pm to consider sale of property at competitive bidding and exited at 6:48 pm.
