At the regular January meeting held on January 22, 2026, Mr. Campbell reported attending the December 11, 2025, Superintendent Executive Committee Leadership meeting to address funding the future held at Ohio Association of County Boards office. He also attended December 12, 2025, Superintendent Executive Committee meeting held at Franklin County Board of Developmental Disabilities. Ohio Department of Developmental Disabilities Director Lindsay Nash clarified citations based on waiting list rules, new MSS launch, Hardship rule, and state funded waivers. Superintendents have requested Ohio Department of Developmental Disabilities transfer Level 1 waivers match the same as Self Empowered Life Funding and Individual Option waivers. Funding the future a mandate for change was discussed with each region to cover in January and address at next meeting January 23, 2026.

The Strategic Plan has an objective to maintain fiscal responsibility by annually discussing the Waiver ceiling. The Board set waiver ceiling of seventy Individual Options, fifty Level 1, and three Self Empowered Life Funding Waivers in 2025. Any waivers requested above this ceiling must be approved by the Board.

- Approved payment of November bills in the General Funds account in the amount of \$20,697.52.
- Approved payment of November bills in the Residential Services account in the amount of \$22,095.58.
- Approved payment of December bills in the General Funds account in the amount of \$57,812.26.
- Approved payment of December bills in the Residential Services account in the amount of \$5,668.95.
- Approved the Program Division Reports as presented.
- Approved the Carroll County Board of DD program calendar 2026-2027.
- Approved Resolution 112026 to set aside funds for the March Developmental Disabilities banquet for awards in the amount of \$2,000.
- Approved Resolution 122026 to set ceiling for Individual Options waivers at seventy, Level 1 waivers at fifty, and Self Empowered Life Funding waivers at three for calendar year 2026.
- Approved entering executive session at 5:59 pm to consider the employment of a public employee or official and exited at 6:14 pm.
- Approved a 5-year superintendent contract from January 1, 2026, to December 30, 2030, with current salary of \$138,620 and addendum for Service and Support Administration Director duties remaining the same at \$30,000.
