At the regular November meeting held on November 20, 2024, Mr. Campbell attended the Superintendent Executive Committee meeting on November 8, 2024, via Zoom. The Ohio Department of Developmental Disabilities updates were waiting list rule (people have to be added even if not eligible for board services), requirement for Level of Care to be completed at time of Waiting list assessment starting July 2025, waiver modernization, access rule Home and Community Based Services, and SSA manual. Ohio Association of County Boards updates on rules, proper public purchases, legislative, and budget.

Mr. Campbell reported the Board currently has no immediate needs and eleven people on the waiting list. Our waiting list has grown from six to eleven even though a person was awarded a Self-Empowered Life Funding (SELF) waiver and another a Level 1 waiver this year. The Board currently has 88 Individual Options Waivers with 18 of the state funded, 37 Level One waivers, and 3 SELF waivers.

Business Manager Ray Heaston reported that the State Auditor completed the review of 2023. The only finding was Carroll County Board of DD did not have a records manager/custodian named in policy. The business manager is now named as the records manager/custodian.

The Ohio Department of Developmental Disabilities accreditation team will be reviewing the Board on December 11 and 12. The required records list was submitted thirty days before the review. This year the focus is on the county board waiting list, eligibility, due process, service planning, behavior support, personnel, major unusual incidents, title XX, and early intervention.
