At the regular September meeting held on September 26, 2024, Mr. Campbell attended the Superintendent Executive Committee Meeting on September 13, 2024, via Zoom. The Special Olympics Ohio Memorandum of Understanding was discussed. County Boards who employ a Special Olympics coordinator who uses the Special Olympics Ohio EIN number for donations were assured money raised locally will stay local. Cleveland is seeking to host the Special Olympics USA Games in 2030 and is seeking pledges for support. Ohio Association of County Board updates included state budget discussion, talk about billing Medicaid for home visiting and Early Intervention, structure of Medicaid rates to keep up with cost of living, 14c subminimum wage resolution and bylaw changes for the delegate assembly.

Business Manager Ray Heaston reported The Board received a Bureau of Workers Compensation security and safety grant of \$5,347.50 for security cameras at Carroll Hills School. The Board also was awarded the County Risk Sharing Authority, Inc (CORSA) cybersecurity grant of \$5,250 to use toward Eagle Consulting cybersecurity contract. Stark Educational Service Center will be getting bids soon. The Board will place an order for a new bus which will come out of the 2026 budget. He went over the 2025 proposed budget. The Hot lunch was zeroed out and will be eliminated since contract with Carrollton Exempted School District for meals. County Health insurance increased by 3.2% in 2025.
