At the regular September meeting held on September 25, 2025, Mr. Campbell attended the Superintendent Executive Committee leadership meeting on 9-4-2025 via Zoom. Ohio Department of Developmental Disabilities Director Lyndsay Nash discussed the need for providers to utilize Electronic Visit Verification in order to get paid starting October 1, 2025. This is a concern since there are independent providers who are not using Electronic Visit Verification. Proposed Administrative Rule would require County Boards to have job positions for provider support and advocacy. The Ohio Department of Developmental Disabilities is moving forward with the interRAI assessment. Timelines are to hire assessors and start sample groups in February and March 2026.

Mr. Campbell stated DSP appreciation week was September 7 through 13. The Board wants to recognize the two hundred and sixty-two direct support professionals that make a difference in people with disabilities lives. Thanks to these staff Carroll County residents get the support at home, in the community, at work, and with transportation to live the best life they can. Thank you for being there!

Mr. Ray Heaston briefly reviewed past and current budgets and suggested passing the 2026 operating budget at next October Board meeting. There was discussion on the proposed budget that would include a reduction in collecting the main operating levy. He is waiting on information to have a more definite budget for the next board meeting.

- Approved payment of August bills in the General Funds account in the amount of \$125,664.94.
- Approved payment of June bills in the Residential Services account in the amount of \$19,354.12.
- Approved the Program Division Reports as presented.
- Approved three new and three renewal applications for Family Selected Services.
- Approved the Resolution 912025 to hold back the 3.6 mill operating levy to 3.1 mills for calendar year 2026 based on current reserve.
- Approved the Resolution 922025 Artificial Intelligence policy.
- Approved the Resolution 932025 Expenditures for Public Use Policy.
- Approved the Resolution 942025 Designated funds for Board meetings and staff in-services for 2025 not to exceed \$3,000.
- Approved the Resolution 952025 to adopt the Carroll County Board of Developmental Disabilities 2025-2026 school year bus routes and stops.
- Approved the Resolution 972025 Non-Federal Share of Medicaid Expenditures in the amount of \$675,000.
- Approved the Resolution 982025 to approve one additional Individual Options Waiver above the ceiling of seventy IO Waivers to address the current needs list.
- No executive session.
